### **KOSMOS ENERGY ENTERS INTO SENIOR SECURED TERM LOAN FACILITY WITH SHELL FOR UP TO \$250 MILLION**

**DALLAS, Texas, September 25, 2025** - [Kosmos Energy](#) (NYSE/LSE: KOS) ("Kosmos" or the "Company") announced today that its wholly-owned subsidiary, Kosmos Energy Gulf of Mexico Operations, LLC ("the Borrower"), has entered into a senior secured term loan facility (the "Term Facility") with Shell Trading (US) Company ("STUSCO" or "Lender"), with funding anticipated on October 1, 2025.

The Term Facility provides up to \$250 million to be used for the repayment of the Company's outstanding unsecured notes. The Term Facility is structured in two tranches, with the first tranche of \$150 million to be drawn at close and used to partially redeem the Company's outstanding 2026 unsecured notes (\$250 million outstanding). A second tranche of \$100 million is available for drawing until April 1, 2026. The Term Facility has an interest rate of SOFR + 3.75%, is secured against the Borrower's assets in the Gulf of America and has a final maturity date of four years after closing.

Neal Shah, Chief Financial Officer, said "We continue to be proactive in improving the resilience of the company's balance sheet in a volatile commodity price environment by raising new liquidity on attractive terms and addressing near-term maturities. With production near record high levels and capital at multi-year lows, closing the Term Loan facility complements our near-term goal of organically reducing net debt through free cash flow generation from our high-quality assets while also continuing to grow our strategic relationship with Shell in the Gulf of America."
